



#### What we don't do

We can't	Who can help
Enroll people in Medicare Parts A & B	Social Security is the place to start
Enroll people into MSHO	Refer people to the health plan they've chosen
Advise people on spenddowns, spousal impoverishment, estate recovery and liens	Counties can help with spenddowns and an elder law attorney can help with legal issues
Assist with cost-effective insurance premiums for Medical Assistance enrollees	This is something counties can manage
Enroll people into a Medigap plan	A person must contact the insurance company, broker or agent selling the policy

#### Housing support

- We support and counsel people when they are making decisions to move or remain in their home.

- Our goal is to help people before a crisis.

#### Help for older adults referral

Helps older adults stay in their home or discharge from a facility

Includes ongoing follow-up

Provides support to family members and caregivers

#### What is PAS?

Preadmission screening (PAS) is required prior to all admissions to Medical Assistance (MA)-certified:



#### Why is a PAS needed?

#### Determines the need for nursing facility care

Most integrated setting

#### Connects people with services

- In the nursing facility
- In their return home

Nursing facility payment and survey

#### Face-to-face assessment needs

Face-to-face assessment from the county before admitting to a SNF


Level of Care Cannot Be Determined

#### Level of Care Redetermination

Nursing facility level of care must be re-established:

#### On MA


 PA1 or PA2 on the 1<sup>st</sup> MDS after admission (90 days)

#### Applying for MA


 PA1 or PA2 on the most recent MDS prior to MA


